924,585 Meals Served Via Child Care Food Program

The USDA Child and Adult Child Care Food Program reimburses Child Care Providers for the meals they serve to the children in their care. Our staff ensures Butte County children are eating healthy and developmentally nutritious meals and snacks, plus helping to lower costs for Child Care Providers.



\$82,550 Of PPE & First Aid Kits

Through PPE Distribution Funds, PPE
Grants, and Public Health & Safety
Funding, VOCS was able to distribute
over 2,675 PPE & First Aid Kits to Child
Care Homes, Centers, and the
Community. Plus, hundreds of Covid-19
Test Kits were distributed to the
community, all year long.


